The Court has further been to direct the Stamp Reporting Section in the fresh filing cases to verify whether copy has been served upon the opposite party or not.

The Court has also been pleased to direct all Judicial Sections of the Court to ensure that while placing office note, the same must bear a specific statement of service or non-service of copy upon other party/ parties.

These directions must be followed strictly with immediate effect by all concerned.
