As you are aware Department of Justice has launched 'Nyaya Bandhu Panel' initiative under Nyaya Bandhu (Pro bono legal services) programme with the aim to setup and create panel of Pro Bono lawyers in the High Courts to ensure a steady stream of pro bono lawyers at the State level. In this initiative, High Court (through its Registrar General), invites applications from Advocates, practicing before the Hon'ble Court, and who are keen to volunteer pro bono legal services to the marginalized, to become part of the 'Nyaya Bandhu panel'.


2. In order to facilitate this scheme, a separate module has been created for Nyaya Bandhu Panel in the home page of Nyaya Bandhu web portal ([www.probono-doj.in](http://www.probono-doj.in)) which consists of login for RGs. The main purpose of this online modules is to register lawyers for making a panel of Pro Bono Lawyers. For activation of the module, the Register General will first have to update profile which will be generated immediately after the first login.

3. This module will be accessible through the respective username and login ID generated by the department and contains sub modules such as dashboards, Pro Bono lawyer registration forms, reports and queries, profile settings etc. The registration of lawyers desiring pro bono services will be done by RG through this sub module. After registration, an online notification will be generated by the system for the respective lawyer for completing process through Nyaya Bandhu mobile application.

4. Data entry into sub modules is to be done by Registrar General or by authorized representative nominated by Registrar General. For your High Court, username is **rg.jhrhc@indiancourts.nic.in** and password is **Rgjhar@1**. You are requested to please reset the password as per your convenience.

5. It is requested to start using the module at the earliest by making data entry. Instructions in the form of a user manual is in the making and will be shared soon. 

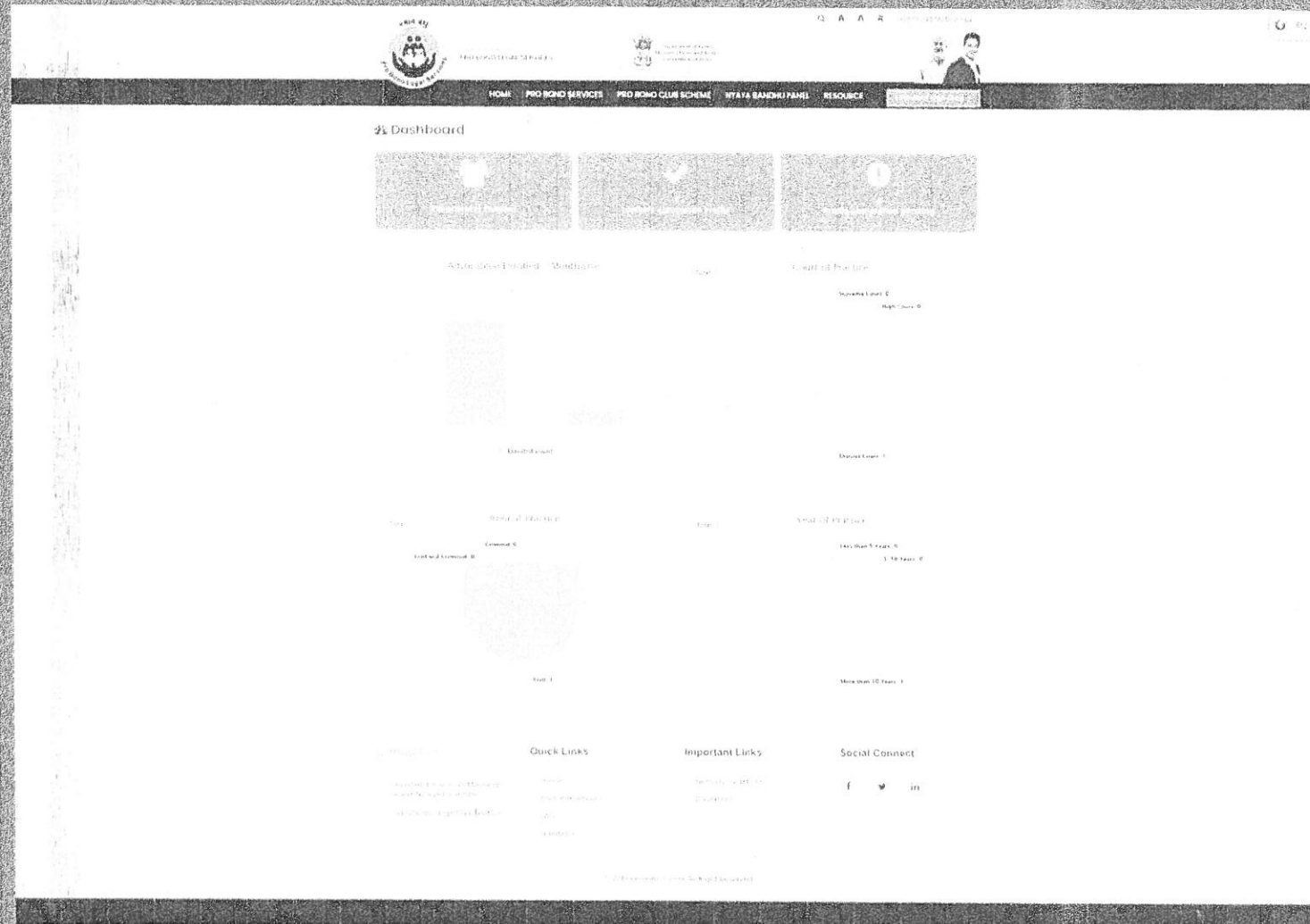
