- Applicants must be employees of Central or State Governments, Governments Companies or Autonomous Bodies or Regulatory Authorities or Universities or Academic or Research or Judicial Institutions etc. of Central/State Governments.
- The appointment will be made on deputation on foreign service terms basis initially for a period of three years and will be governed by the instructions issued by the Department of Personnel and Training vide O.M. No.6/8/2009-Estt. (Pay II) dated 17.06.2010, as amended from time to time. The maximum age limit for appointment to the post of Adviser on deputation basis shall be not exceeding 58 years as on the closing date of receipt of applications by CCI.
- Apart from basic pay and grade pay, the post carries DA, HRA and Transport Allowance etc. as per the rates applicable to the Central Government employees from time to time. Medical reimbursement is admissible as per the CCI service rules. This is in lieu of CGHS benefits which are not admissible to the employees of CCI. The CCI is an eligible office for allotment/retention of Government Accommodation from General Pool.
- The application in the prescribed pro-forma, (Annexure-II), together with all necessary 5. documents i.e. cadre clearance, vigilance clearance, copies of APARs of last five years and Certificate from the Employer may be sent to the undersigned at the address indicated above, through proper channel, latest by 29th November, 2019.
- Those candidates who have applied earlier for appointment to the post of Adviser 6. (Financial Analysis) in CCI on deputation basis in response to the vacancy advertisement issued on 05.04.2019 need not apply afresh against this advertisement.
