- 4. The 2<sup>nd</sup> senior most Assistant Registrar (Non-Judicial) available on roster duty shall remain in-charge for countersigning Bail order(s) / any urgent order during the exemption period of regular Assistant Registrar assigned such duty.
- 5. The I/c Receiving Section shall make arrangement for receiving of important Dak / letters of this Court by their staff during the holidays.
