- 2. Opening date of Tender:

a. Technical bid

: On next working day in the chamber of the Registrar (Establishment).

b. Financial /Price bid

: On next working day after the opening of Technical Bid, in the chamber of the

Registrar (Establishment).

Tender fee (non refundable)

: Rs. 500/- (Rupees five hundred only) by way of demand draft drawn in favour of

"Registrar General, Jharkhand High Court" payable at Ranchi.

- Security Deposit: The successful bidder will be asked to furnish Security Deposit of 3% of total value of work order, which is refundable. It is to be deposited by way of bank draft drawn in favour of "Registrar General, Jharkhand High Court" payable at Ranchi. The Security Deposit would be returned after the completion of financial year 2022-2023.
- 5. Eligibility Criteria for bidder:

a. Experience

: 05 years experience in supply of Goods to Government/PSU/Corporation/Board etc.

Financial Turnover: Rs. 20,00,000/- (Rupees twenty lakh only), which will be calculated on average of 05

consecutive financial years i.e. 2017-2018 to 2021-2022.

c. SSI/MSME Registration etc.: Having Small Scale Industry (SSI) / Micro, Small and Medium Enterprises (MSME) registration at Jharkhand.

- 6. Self attested copies of the documents regarding eligibility criteria must be enclosed with the Technical Bids.
- 7. The tentative annual requirement of the goods may increase or decrease depending upon demand.
- 8. The successful bidders are bond to supply articles on quarterly / half-yearly/ annually basis or as and when required depending upon the requirement.
- Bidder should submit tender/s for one or both categories with separate tender fees.
- 10. The cover containing technical and financial bid should be superscribed as "Tender for supply of Stationery / Miscellaneous Housekeeping articles".
- 11. The rate quoted in the tender should be inclusive of all taxes, freight charges etc.
- 12. The rate of the articles quoted in tender will remain valid till 31/03/2023 or the finalization of the next tender. The successful bidder shall be bond to supply the articles at the approved rate for this period, which may be extended for further period, if agreed
- 13. The goods/articles shall be delivered to the Hon'ble High Court, Ranchi on Door Delivery basis. Unloading of the goods and delivery to store shall be responsibility of the firm.
- 14. The goods/articles should be in good condition of specified specification having the original packing intact.
- 15. The supplier will be liable to replace the rejected/damaged supply or articles not as per specification within a week, failing which the legal action will be taken as deemed fit by the Hon'ble Court.
- 16. Payment will be made through Bank Account, not in cash after delivery and inspection of goods.
- 17. The Court reserves the right to reject or to accept any tender, in whole or in part without assigning any reason thereof and the tender fees will be forfeited.
