The fixation of pay/deputation (duty) allowance shall be governed by instructions issued by DOP&T from time to time. Medical reimbursement is admissible as ger the CCI service rules. This is in lieu of CGHS benefits which are not admissible to the employees of the office of DG, CCI.
